

PAYG Holiday Bolt-On Updated September 2023 Terms & Conditions

The Airtel-Vodafone PAYG Holiday Bolt-on – Terms and Conditions should be read in conjunction with the Airtel-Vodafone Pay-As-You-Go (Pre-paid) Service Terms and Conditions as highlighted under the Terms and Conditions links on www.airtel-vodafone.com.

Where there is conflict between the Airtel-Vodafone PAYG Holiday Bolt-on Terms and Conditions and Airtel-Vodafone Service Terms and Conditions, the specific Terms and Conditions for the Airtel-Vodafone PAYG Holiday Bolt-on shall apply, but all other provisions within Airtel-Vodafone Service Terms and Conditions shall remain in full force and effect.

1. There are two versions of the Holiday Bolt-On, detailed below. Customers can add to their PAYG number (excluding data and FWP plans)
2. The **19.99 Holiday Bolt-on** is valid in: Aland Islands, Albania, Austria, Belarus, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Isle of Man, Latvia, Lithuania, Luxembourg, Macedonia, Malta, Netherlands, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia, Spain, Sweden, Turkey, Switzerland, UK, Ukraine and USA.

The 19.99 Holiday Bolt-on gives the allowances below, valid for **7 days**, and does not include any credit amount:

- **1GB** Roaming Data
- **50** SMS – Worldwide
- **50** Mins Outgoing Call Time to any number within the roaming country i.e Customer roaming in UK and calling a UK number, or if a customer is roaming with the country and calling home, eg UK -CI (calls to premium and special numbers are not included will be rated as the standard premium and roaming rates which can be found on www.airtel-vodafone.com)
- Free incoming calls worldwide whilst in UK and France

3. The **£9.75 Holiday Bolt-on** is valid in: Aland Islands, Albania, Austria, Belarus, Belgium, Bosnia & Herzegovina, Bulgaria, Croatia, Cyprus, Czech Republic, Denmark, Estonia, Finland, France, Germany, Greece, Hungary, Iceland, Ireland, Italy, Isle of Man, Latvia, Lithuania, Luxembourg, Macedonia, Malta, Netherlands, Poland, Portugal, Romania, Serbia, Slovakia, Slovenia, Spain, Sweden, Turkey, Switzerland, UK, Ukraine and USA.

The £9.75 Holiday Bolt-on gives the allowances below, valid for **3 days**, and does not include any credit amount:

- 500MB Roaming Data
 - 25 SMS – Worldwide
 - 25 Mins Outgoing Call Time to any number within the roaming country i.e Customer roaming in UK and calling a UK number, or if a customer is roaming with the country and calling home, eg UK -CI (calls to premium and special numbers are not included will be rated as the standard premium and roaming rates which can be found on www.airtel-vodafone.com)
 - Free incoming calls worldwide whilst in UK and France
4. To add and receive the above allowances, the customer must top up with £19.99 or £9.75 only via www.airtel-vodafone.com
 5. Any usage outside of the destinations, allowances and validity periods above will be deducted from the customer's credit prevailing balance at standard roaming rates.
 6. Once the 7/3 day validity period has finished, the customer may choose to top up £19.99/£9.75 to repeat the allowance and benefits.
 7. Airtel-Vodafone reserves the right to remove these bolt-on at any time.
