Terms & Conditions

The Airtel-Vodafone “UNLIMITED Islander Plan Plus” Terms and Conditions should be read in conjunction with the Airtel-Vodafone General Pay Monthly or Post-Paid Terms and Conditions as highlighted under the terms and conditions links on www.airtel-vodafone.com.

Where there is conflict between the Airtel-Vodafone “UNLIMITED Islander Plan Plus” Terms and Conditions and the General Airtel-Vodafone Pay Monthly Terms and Conditions, the specific Terms and Conditions for the Airtel-Vodafone “UNLIMITED Islander Plan Plus” shall apply, but all other provisions within the General Airtel-Vodafone Pay Monthly Terms and Conditions shall remain in full force and effect.

The “UNLIMITED Islander Plan Plus” is available for new Guernsey Airtel & Jersey Airtel Customers.

Customers on this plan can enjoy unlimited* Calls and SMS to all CI/UK numbers (excluding premium, low rate and special numbers) plus unlimited local data at the maximum speed available. Please refer to the table below for details

1. The UNLIMITED “Islander Plan Plus” is available to new customers who sign a Pay Monthly contract with a minimum term of 12 months. A new customer is defined as a customer switching their existing mobile number from an alternative service provider or taking a new mobile number.
2. The Bundled Minutes, SMS and Data included within the “UNLIMITED Islander Plan Plus” must be originated from the Channel Islands and do not include roaming usage. Roaming usage will be charged as per the standard rates published on www.airtel-vodafone.com
3. The bundle excludes International Calls, International SMS, Premium Calls and Voicemail services. Any usage outside of the monthly Bundled Minutes will be charged as per our standard rates as defined on www.airtel-vodafone.com
4. Out of bundle Calls will be rated with a per minute pulse.
5. This is a retail Plan and is not available to any type of corporate business, any misuse of services can result in services being withdrawn with immediate effect.
6. Tethering/hot spotting (sharing the mobile data connection with another device) is not permitted on this Plan. We reserve the right to suspend or terminate the service in such instances.

7. The Plan is designed for use in a mobile handset only – if we discover that the sim card is being used in a router we reserve the right to suspend or terminate the service.
8. *The Acceptable Use Policy is defined as below:
 - If Guernsey Airtel Limited or Jersey Airtel Limited becomes aware of usage that gives cause for commercial concern or in our reasonable opinion, we establish any of our services are being used in a way for which they were not intended, or are excessive for mobile usage, we reserve the right to apply traffic management policies in relation to mobile data
9. This plan can be withdrawn by Guernsey Airtel and Jersey Airtel Limited at any time.
